Book Trust is a teacher-led, student-driven national early literacy program which includes a step-by-step supported and evaluated process to ensure students have the opportunity to discover the joy and power of reading. In the 2023-2024 school year, 58,106 Book Trust elementary students in 194 schools across 15 states, selected and received over 630,000 new Scholastic books. Book Trust students were able to build their love of reading and their own home libraries.
